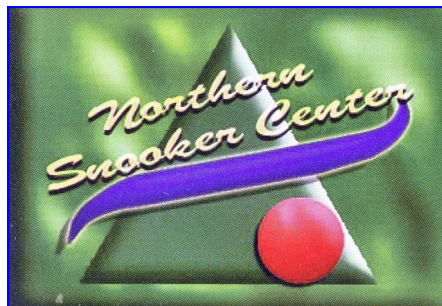

YORKSHIRE BILLIARDS & SNOOKER ASSOCIATION STANDING CONDITIONS

1. (a) All contestants taking part in Y.B. & S.A. Leagues and Competitions must be non professional players and registered members of clubs situated in the designated area of YORKSHIRE. The contestants must have been registered by that club before the commencement of the current season of all Y.B. & S.A. fixtures. (b) The contestant's Home club must be affiliated to the Y.B. & S.A. either by way of the local Billiards & Snooker League, or as a privately affiliated club. (c) Entrants to any Y.B. & S.A. controlled Leagues or Competitions must not enter any other County Leagues or Competitions in the current season of all Y.B. & S.A. fixtures. (d) Failure to abide by any part or parts of these conditions will result in immediate disqualification.

2. (a) All games must be played on a standard table, using balls which conform to current specifications, and under the rules published by the World Professional Billiards & Snooker Association and ratified by the International Billiards & Snooker Federation. (b) Games must not be played on private tables.

3. All matches must be played at clubs where ladies are allowed in the snooker room as players, officials or spectators. Players under the age of 18 years will need prior permission from the host venue at which the match is to take place, and a player under the age of 18 years must be accompanied by a responsible adult. In the event of these conditions being unacceptable to the Home club, it is the Home player's or the Home team captain's responsibility to arrange a venue where these conditions are favourably received.

4. In the event of an official referee not being in charge of a match, a nominated referee may be mutually agreed upon by the players or team captains involved in the match. Upon agreement by the players or captains involved, the nominated referee's decision shall be final.

5. When matches are not required to be played on neutral tables, the first named player in the draw shall, within seven days of notification, offer a choice of three (3) non-consecutive dates and start times to ensure completion by the date notified. Failure to do so gives the AWAY player the right to claim the HOME venue. The opponent is required to accept one date within a further three (3) days. It is the responsibility of the WINNER to notify the Y.B. & S.A. Secretary within 24 hours. If matches have not been played by the closing date and no information has been received, BOTH PLAYERS WILL BE DISQUALIFIED.

6. Lateness to all organized matches will be penalized as follows: SNOOKER If not present at the start time one frame shall be forfeited. 15 minutes after the start time, a further frame shall be forfeited. 30 minutes after the start time, the match shall be forfeited. BILLIARDS If a player is not present at the match table 30 minutes after the starting time, the game shall be forfeited. TEAM Additionally, in team competitions, players must be present so that play shall be continuous, otherwise time penalties as above will apply, alternatively, a reserve may be substituted.

7. When matches are played on neutral tables, the appointed official shall be responsible for notifying the result.

8. OUTRAGEOUS OR UNKEMPT APPEARANCE WILL NOT BE PERMITTED, INCLUDING THE WEARING OF DENIM JEANS, TEE SHIRTS, TRAINERS OR SIMILAR FOOTWEAR. Acceptability of dress will be at the discretion of the Tournament Director or Head Referee present and if considered unsuitable the player may be disqualified. Qualifiers for the latter stages of the competition will be informed of specific dress requirements.

9. Entries will only be accepted by sending the completed form to the Y.B. & S.A. Secretary. Entries must be received by the Association by the closing date notified.

NOTE; No late or telephone entries will be accepted. No entries will be accepted without receipt of entry fees with the entry form.

10 The format of play will be sent with the draw.

11. Dates and venues may be changed at the Association's discretion.

12. The Association shall reserve the right to refuse an entry.

13. CONTESTANTS ARE WARNED THAT DRUG TESTING MAY TAKE PLACE.

14. Advice on banned substances may be obtained from the Y.B. & S.A.

15. Entries shall be regarded as acceptance of these rules and conditions, and in the event of any dispute arising, or any other matter,

16. THE DECISION OF THE ASSOCIATION SHALL BE FINAL.
